SUBMISSION (BRAZILIAN FILMS ONLY)

Please read this form carefully. You are required to provide a signed copy of this form with your film submission. By signing this form, you are attesting that you have read and understand the submission terms.

1. ELIGIBILITY REQUIREMENTS: To be eligible for consideration, all films must meet the following requirements:

- i. Have not been/will not be previously screened commercially in North America nor available on the Internet.
- ii. Be in their original language with English subtitles if the original language is not English. In some cases, exceptions may be granted. If you are unable to provide an English subtitled version, please contact nwcs@hightreasonproductions.com.
- iii. Have a running time in excess of 70 minutes. Short Films will not be reviewed.
- iv. Be a completed film. NWCS will not review unfinished movies and does not provide finishing funds.

2. SUBMISSION FORMATS: For programming consideration, the NWCS accepts DVD (Region 4/ Latin America, Region 1/ North America, Region 0/ No Region) of the completed film. Please test computer-burned DVDs on several makes and models of players before sending. DVD+RW and DVD-RW discs are not accepted. The NWCS will not consider trailers for selection purposes. DVDs must be labeled with title, year of production, contact name, address, telephone number, email address, director's name, country of origin and length in minutes.

3. SUBMISSION MATERIALS: Please include the following materials with your submission (Make sure there is also an English version of the texts):

- i. One DVD with labeling as described in Clause 2 above.
- ii. A signed printout of this Submission Form.
- iii. Providing additional press materials, including director, screenwriter and cast bios is preferred, but optional. Producers and their agents are responsible for the accuracy of all submitted materials. The NWCS accepts no liability in the event that its publications reproduce inaccuracies in submitted materials. You may be contacted for additional material prior to and following selection. Should you be informed that your film has been selected, you will be required to submit extensive publicity materials. A complete list of required materials will be sent to you at that time.

OPTIONAL: Filmmakers are encouraged to fax (1.323.556.0827) or e-mail (nwcs@hightreasonproductions.com) Submission Form prior to mailing a hard copy.

4. DEADLINES: The submission deadline for selection purposes is the 28th of February 2009.

5. RETURN OF MATERIALS: Preview DVDs will not be returned.

6. SELECTION: NWCS Programmers select and invite all films. Filmmakers selected to participate will be notified by the 31st of March 2009. Filmmakers not selected will be notified by email.

Submission of your film does not guarantee that the NWCS will select your film for participation. If you are notified of your selection in the NWCS, you will be provided with a distribution licensing agreement. You will be required to indicate your acceptance of the licensing agreement within 15 days of receiving the document. NWCS does not pay upfront minimum guarantees for the licensing of films.

7. ANTI-PIRACY PRECAUTIONS AND RELEASE: The NWCS endeavors to take all reasonable anti-piracy precautions. While on NWCS premises, copyrighted materials are securely stored. Access is limited to our submissions and programming staff. No duplication or loaning is permitted. By submitting your material to the NWCS, you hereby release the NWCS from any and all risk and liability in the event of theft or breach of copyright of your materials while on NWCS premises.

8. EXCERPTS: Permission for excerpts not exceeding three minutes to be used for internal NWCS promotional purposes is granted upon entry, unless otherwise stated.

9. SHIPPING OF PREVIEW SUBMISSIONS & INVITED FILMS:

i. All packages containing DVDs must be marked clearly with the title of the film and sent to:

ii. All submissions must be sent PREPAID. The NWCS will not accept collect shipments.

iii. The NWCS will not assume responsibility for, nor will it accept, shipments incurring expenses for terminal charges, duties, taxes or customs brokerage. Clearly indicate on all waybills that transportation and customs charges be billed to the sender.
